## STATEMENT OF CLAIM

The Plaintiffs seek a declaration that:

- a. The 1st Defendant is subject to the Public Procurement Act, 2003 (Act 663) as amended;
- b. The failure of the 1st Defendant to comply with the Public Procurement Act, 2003 (Act 663) as amended in its engagement with the 2nd Defendant is in breach of the Public Procurement Act, 2003 (Act 663) as amended.
- c. The large forex transactions between the 1st and 2nd Defendants ought to have been subject to the Public Procurement Act, 2003 (Act 663) as amended, and, to the extent that they were not, are in breach of the same legislation.
